- 2. This approval relates to the manufacture of door frames for use with specified CERTIFIRE approved fire doors. Subject to the undermentioned conditions, the doors when fitted in the frame and with hardware and intumescent seals as specified in the CERTIFIRE door leaf certificate are designed to meet the requirements as detailed in the relevant certificates.
- 3. The door frames for use with 30 minute fire doors shall be manufactured from softwood, with a minimum density as defined in the CERTIFIRE Data Sheet for the door leaf being utilised
 - All frames shall be manufactured in accordance with the frame specification, including minimum section sizes, as defined in the CERTIFIRE Data Sheet for the door leaf being utilised, having regard to the maximum door leaf sizes and configurations permitted with softwood frames under the door certification.
- 4. The door frames for use with 60 minute fire doors shall be manufactured from hardwood (Please note that timber species exclusions are applicable in accordance with Table 2) with a minimum density as defined in the CERTIFIRE Data Sheet for the door leaf being utilised
 - All frames shall be manufactured in accordance with the frame specification, including minimum section sizes, as defined in the CERTIFIRE Data Sheet for the door leaf being utilised, having regard to the maximum door leaf sizes and configurations permitted with hardwood frames under the door certification.
- Frames are to be fitted with CERTIFIRE approved intumescents, in accordance with the type, size and location requirements stated within the CERTIFIRE Data Sheet for the door leaf being utilised.
- 6. Frames are suitable for use with door leaves fitted with a single point latch / lock only (multipoint / espagnolette locks are not permitted).
- 7. Processing is conducted in accordance with Mike England Timber Co. Limited procedures.
